Minutes from Previous Meeting

- Minutes from the 6/21/24 meeting were reviewed. A motion was made to strike the election of officers and approve the minute by Bill Klug and seconded by Barry Geary. Motion pass.
- Minutes from the 12/20/24 meeting were reviewed. A motion to approve the minutes was made by Keven Stelzel and seconded by Joe Worzala

Treasurers Report

- Finances for the year were sent by Treasurer prior to the meeting.
- Changes were made to the mechanics of finances to drive efficiency and improved accounting principles for the club, and were reviewed by an accountant
- Now operating the club through a cash box. Checks can be cashed through West Town Archery and Fred.
- Continuous tracking of accounting of the cash box completed by Eric
- Current balance is \$5,907.89
- Targets for the club were the largest expenses for the club at \$1591.35
- Club purchased video equipment for sports show content creation for \$1,600.00
- Admin/Socials costs remain low, and club is available to spend available funds

Presentation of Bills

- Club is current to known expenses

Committee Reports

- Sports Show
 - Overall great event, and member participation were appreciated
 - Over 200 Participants in the headwinds of being scheduled at the same time as the Vegas Shoot. That exceeded expectations.
 - Damage issue at Sports Show with arrow that impacted steel door, and was covered by West Town Archery's Umbrella Coverage.
 - Will not be covered by Shop Insurance in the future.
 - Club will need to find plan to cover doors at next year's event.
 - No issues from Sports Show event runners
 - Zach Jeske request of updated laptop to better operate the streaming capability, and access to sports show Wi-Fi
 - Thanks to Greg F, and Randy for taking photos during the event
 - Discussion of options of expanding streaming service broader than Facebook. Many options, and will have to determine the most appropriate path forward for the club.
- Sports Show Warmup
 - Last year 3 Days of shooting, and only 26 Vegas & 15 Bowhunters
 - Proposal for next year to reduce to 2 days, and will be executed.
 - Date will be set after the next KM Schedule Meeting to fit into off weekend.
- Carp Shoot
 - Went well, but less carp shot
 - 53 Attendees
 - Greg has photos and will send to Fred.
 - Venmo worked well, but has complexities
 - Club paid entry fees for members, and club will be covering the cost of disposal.

Elections

Al Jeske proposed a constitutional amendment to address this timing, and he asked Eric to draft the amendment for vote at our December meeting.

Due Structures

- Benefits will be updated to include payment of carp shoot fees buy the club for members.

- Motion to approve the dues structure by Zach Jeske and seconded by Fred Schaffhauser. Motion pass.

Old Business

- Discussion in regard to creating membership cards, and login access to the westtownarchery.com club page.
- There was agreement that the complexities of building secure access to the club page exceeds the benefits. There was also agreement that membership card provide no demonstrable value.
- The membership had open discussion of hosting an outdoor shoot at another club.

New Business

- Members receive a new range card annually from the shop. Barry Geary proposed using club funds to purchase additional range cards for members, so they have unlimited shooting privileges similar to other organizations.
- It was discussed that members can already have the benefit of purchasing additional range cards at half price, and staff shooters already have unlimited shooting privileges.
- Barry Geary made a motion to test the use of club fund to purchase additional range cards through the end of the calendar year with a review at the December meeting. Seconded by Rob Schaffhauser. Motion pass.
